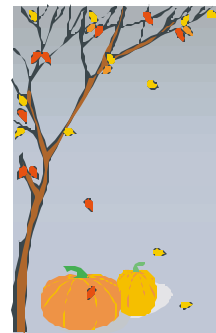

The Board includes seven volunteer members elected by the membership community. Each serves a 3-year term. There is no pay for the Board members. Officer positions are determined on a yearly basis by the new board. Westleigh operates on a fiscal year that runs from November 1st through October 31st. Elections occur each year at the annual meeting. Three paid subcontractors serve Westleigh and the Board. They are the Clubhouse Manager, the Membership Manager, and the Bookkeeper.
